Conference rules

Papers and presentations for the international scientific conference Trends in Furniture and Living 2024 are only accepted in English (papers must be written in British English). SI units must be used; L (litre) can be used for I (litre), example: link; use typography for English scientific texts link. The referencing style used is ISO 690-2 and an example is provided in the paper template.

Received manuscripts will be evaluated by at least two independent blind reviewers within the following periods:

- The abstract will be evaluated within 14 days.
- The full paper will be reviewed within 3 weeks from receipt of the final article. •

Ethics

Ethical behaviour is observed pursuant to COPE Ethical guidelines throughout the evaluation of the conference paper link.

Authors

The author and co-authors must be familiar with the content of the published article and are responsible for it. They declare that they are submitting the article together. The article is the work of the author or co-authors, it is original and has not yet been published anywhere, it has not been sent for publication, it will not be sent for publication, and it is not undergoing another review process (in any language).

The authors and co-authors undertake to send the submitted title / abstract / manuscript in scientific English in compliance with the template after it has been proofread. The author and co-authors agree to proofreading, if necessary.

The author and co-authors declare that the published article does not violate copyright, does not contain defamatory or racist content, is not illegal and does not interfere with the rights of third parties.

With the consent of the co-authors, the authors transfer the license rights to the article to the publisher of the proceedings. The author will send his consent by email to the editorial board at dnynabytku@mendelu.cz

Sources and materials protected by copyright law are properly cited.

The author must inform the editorial board of any fundamental errors that affect the published article, and the board will recommend reworking the article or suggest its withdrawal (this measure is also taken in the event of a successfully published article in the proceedings; subsequent steps will be handled individually).

Self-citation of the author or co-authors is only allowed in the amount of 10% of the total citations.

Reviewers

The review process will be objective, the evaluation of the abstract / full paper will conducted in a timely manner, without personal gain or conflict of interest and with regard to confidential documents / information.

The peer review will be based on objective comments that aim to improve the assessed paper and advance scientific knowledge. If deficiencies are found, the paper will be sent back to be revised. If the paper has serious deficiencies, it will be completely rejected for publication.

The review process will be free of prejudice, personal attacks, politics, religion and gender, and free of any relationships or connections to the authors; only the intellectual content of the paper will be evaluated.

Publisher

The publisher supports the publishing activity of the authors; in the event of unethical behaviour, scientific failure, plagiarism or violation of the copyright law, the editorial team will conduct an investigation and ensure that the situation is remedied by correcting errors, flagging the article with the publication of the error or withdrawing the article. The publisher takes measures to prevent the publication of articles that are in conflict with research activity.
